

DOGGY DAYCARE AND BOARDING TERMS OF AGREEMENT
COCO AND TOTO

Here at COCO AND TOTO, we are committed to making sure that your dog is safe, happy, and has a wonderful time during their stay with us. As part of that commitment, we want to inform you that there is some risk of injury to your dog while he or she is in our care. Dogs can sometimes be injured while playing together, getting scratched or cut, or spraining a joint, and even though such injuries are infrequent and generally mild, they can occur even under very close supervision. We also want to assure you that every dog in our daycare is adamantly screened for aggressive behavior. However, even the gentlest of dogs can sometimes get into fights, sometimes at no provocation and with very little or no warning.

We are a licensed and insured pet boarding facility, and as such we require that every dog in our daycare be up-to-date on both their Rabies and Bordatella vaccinations. For this reason, we must request to keep a copy of these records in your file, along with your dog's vet information and number in case of an emergency. Despite these precautions, it can be possible for dogs to pass various illnesses to each other, even with all required vaccinations and boosters, much like how the flu can be easily passed in a daycare for children.

Accordingly, we ask that you understand and agree to the following:

- ___1. I agree that COCO AND TOTO will not be liable for any claims of injury, illness, damage or death to my dog(s) during their stay and that under no circumstances will COCO AND TOTO be liable for consequential damages, except for circumstances resulting from negligence by COCO AND TOTO.
- ___2. I certify that I have informed COCO AND TOTO of all aggressive behaviors in my dog(s), whether towards humans or other dogs, to the best of my knowledge. I agree that I am responsible for any harm caused by my dog(s) while in the care of COCO AND TOTO, and that I shall indemnify COCO AND TOTO against any claims made against it or for losses or damages suffered by COCO AND TOTO as a result of my dog's behavior.
- ___3. I understand that, in the event my dog(s) appear(s) to be ill, injured, or at significant risk of experiencing a medical problem, COCO AND TOTO will attempt to contact me for instructions prior to seeking veterinary care. If I cannot be reached, I agree that COCO AND TOTO may use its reasonable discretion in seeking veterinary care on my behalf and that I will be responsible for all related expenses. I understand that COCO AND TOTO will attempt to use my preferred veterinarian, but if my preferred veterinarian is unavailable or if other circumstances mandate, I authorize COCO AND TOTO to use a veterinarian of its choice. I agree that COCO AND TOTO will not be liable for the actions and decisions of the veterinarian. I also agree to be responsible for any reasonable fees assessed by COCO AND TOTO for emergency care and transportation.
- ___4. I authorize my veterinarian to share the medical records of my dog(s) with COCO AND TOTO and other veterinarians. I assume full responsibility for payment of all veterinary services rendered, including, but not limited to, diagnosis, treatment, necessary grooming, medical supplies, transportation and boarding. I agree to make such payments directly to the attending veterinarian or to reimburse COCO AND TOTO if direct payment cannot be made.
- ___5. I authorize the use of spray water bottles and crate time outs as corrective tools to prevent escalation of inappropriate daycare behavior, and I understand my dog must have a quick release collar on (provided by me) while in daycare.

This agreement and waiver is valid from the date below and grants permission for future veterinary care without the need for additional authorization each time COCO AND TOTO cares for my dog(s).
